

National Arts Council (NAC) - University of the Arts Singapore (UAS) Arts Scholarship (for full-time undergraduate and postgraduate students)

Terms and conditions

- 1. The NAC-UAS Arts Scholarship is a joint scholarship established between the University of the Arts Singapore (UAS) and the National Arts Council (NAC) to nurture outstanding students enrolled in UAS undergraduate and postgraduate programmes, to develop the next generation of arts leaders in Singapore.
- 2. The NAC-UAS Arts Scholarship is open to Singapore citizens and permanent residents enrolled in UAS full-time undergraduate and postgraduate programmes as listed below:
 - BA (Hons) Acting
 - BA (Hons) Art Histories and Curatorial Practices: Asia and the World
 - BA (Hons) Arts Management
 - BA (Hons) Contemporary Chinese Theatres
 - BA (Hons) Fine Arts
 - BA (Hons) International Contemporary Dance Practices
 - BA (Hons) Music
 - BA (Hons) Musical Theatre
 - MA Art Therapy
 - MA Arts and Cultural Leadership
 - MA Arts and Ecology
 - MA Arts Pedagogy and Practice
 - MA Asian Art Histories
 - MA Creative Writing
 - MA Fine Arts
 - MA Music Therapy
 - MFA Fine Art

3. Scholarship award quantum

- a. 90% of the total fees payable as stated in the official fee advice for the enrolled programme, as well as a monthly maintenance allowance.
- b. Scholarship recipients must maintain a Cumulative Grade Point Average (CGPA) of at least 4.0 every academic year, and maintain good conduct throughout his/her course of study in order to renew the scholarship up to a maximum of two years for the MA programmes or three years for the BA programmes or the minimum duration required to complete the course, whichever is shorter.

4. Service commitment

- a. Scholarship recipients must commit to two (2) years in the Singapore arts industry upon graduation.
- b. Scholarship recipients will be required to submit a Service Commitment Report at least six months prior to graduation, and on a regular basis for two years after graduating from their respective enrolled programmes.
- c. NAC and UAS take a serious view of scholarship recipients who do not fulfil their service commitment and reserve the right to recover funds where necessary.

5. Other conditions

- a. Scholarship recipients will not be eligible for a government bursary, i.e. Higher Education Community Bursary (HECB) or Higher Education Bursary (HEB).
- b. Scholarship recipients who voluntarily intermit/defer or withdraw or are dismissed from the programme will be required to refund the full scholarship amount and monthly maintenance allowances that have been disbursed.
- c. For scholarship recipients who voluntarily intermit or defer their studies, the scholarship will not be carried forward to subsequent semester(s)/academic year(s). The student may apply for other scholarships or bursaries when he/she resumes studies, if eligible.
